

Instructions on how to complete your CREST Transfer Form

If you hold more than one share certificate for the same company's shares, you only need to complete one CREST Transfer Form for the total holding in your name. If the shares are in different peoples' names, you need to complete one CREST Transfer Form for each person.

If you have ever reported your certificate lost or stolen (even if you've then found it) please contact the registrars before taking further action otherwise settlement could be delayed.

Please follow the instructions below and complete the form in ink using block capitals.
